Major Research Findings (briefly)

- Writing a comprehensive introduction to Rabbi Joseph Ibn Sayyaḥ's responsa, a 16th century Musta'rib rabbi, introducing the first study ever dedicated to a Musta'rib Halakhic work. Several earlier historical studies sought to rely on this work as an historical source. However, my research proved that a substantial share of the questions found in the corpus were fabricated, and are not an actual depiction of an historical reality.
- Placing "the late Genizah" on the research agenda. A majority of Genizah researchers focus on its classical period (the 10th-13th centuries). Throughout my research I urge not to neglect the late Genizah documents, which I research intensively. As a result, the discourse in this field of research is slowly changing. In a comprehensive article (Arad, a Rare Light), I surveyed the trends in the study of the Late Genizah and the significant momentum its research has gained recently.
- New studies on Jews from the Mamluk period. These studies include research devoted to specific communities (Jerusalem; Cairo; Alexandria), research on general issues, like the ways in which Jews dealt with anti-Jewish legislation, or the way Jews related to Muslims and the Muslim domain. I have published many new documents from this period in Judeo-Arabic and Arabic as part of my research.
- A series of papers on Musta'rib Jews that comprehensively revealed their family life and communal institutions. Very little research up until now has been devoted to the Musta'ribs themselves, aside from their relationship with other ethnic groups. My research filled a gap in the study of Jews in the late Mamluk state and Ottoman Empire, and drew the academic attention to an unknown group. Among others, my research uncovered a communal notebook from the late 16th century that belonged to the Musta'rib community in Cairo. I gathered its papers, which were dispersed throughout different collections of the Cairo Genizah, and conducted a thorough analysis of its content.
- Revealing and publishing texts in new languages found in the Cairo Genizah. A Halakhic Sephardic text (in Hebrew letters) written prior to the expulsion of Jews from Spain, and a Turkish-Arabic dictionary written in Hebrew letters.
- Analyzing a Hebrew lamentation on the destruction of a synagogue. This specific lamentation is commonly attributed to the destruction of a synagogue in Jerusalem following an earthquake, but my research proved that it was written about a synagogue in Damascus destroyed by the



authorities. Furthermore, I uncovered the relationship between this lamentation and a Judeo-Arabic lamentation cited by Jews in Damascus and demonstrated the contribution of these lamentations to the general discussion on patterns of collective memory among Jewish communities in Muslim countries.

- Publishing a collection of documents in Arabic and Judeo-Arabic from a Collection held at the Oxford Library. This publication substantially enriches the existing body of Jewish letters from the Mamluk era, paving the way for a range of future research by scholars. These studies can delve into areas such as the economic history of the Mediterranean, the Judeo-Arabic dialect of the late Middle Ages, and the intricacies of Jewish communal life during that period.
- In recent years, I have published several studies that seek to view the Karaite diaspora in the Early Modern period as one society. Previous studies have mostly dealt separately with the Karaites of the Ottoman Empire and the Karaites of the Polish-Lithuanian Commonwealth. In my research, I examined the connections between the Karaites in these two political entities, traced the routes through which information passed from one community to the other, and attempted to reconstruct the imagined Karaite world map that the Karaites held in their consciousness.

16. Future Goals (briefly)

- I hope to write a monograph on the Musta'rabic Jewish community in Egypt during the sixteenth and seventeenth centuries, based on numerous Genizah documents that I have found and deciphered. This research will provide us with a portrait of a community in a central Ottoman city (Cairo) alongside several other communities in Egypt and will allow us to understand in a more complex way the Jewish mosaic in the empire, which included various Jewish denominations living side by side.
- As part of my research on the Jews of Damascus during the Ottoman period, I have studied documents from the late Ottoman period pertaining to the Jewish community in Damascus, preserved in the Ben-Zvi Institute collection, and I plan to publish a selection of them. I have already begun preparing this book: I have already deciphered dozens of documents and added notes, explanations, and historical background to each document. Thanks to the research grant I received, the book will be published with excellent graphic quality, accompanied by color photographs of the documents.
- I plan to continue my research on the Judeo-Arabic letters of the Karaites in the communities of Jerusalem, Damascus, and Cairo, which have been preserved in the Firkovitch Collection at the Russian National Library, and to try to understand through them in a deeper way the nature of the relations between Rabbanites and Karaites during this period, as well as the communal and cultural history of the Karaites in the Ottoman Empire.
- I am planning two future research projects. The first will deal with deeds of the Jewish courts in Egypt during the sixteenth and seventeenth centuries, and will make accessible to the general



public copies of these documents, their translation into English, and a detailed index that will help to easily access the historical information contained therein.

The second study will focus on Arabic documents preserved in the archives of the Jewish community in Cairo. These documents, which contain much information about the sale and purchase of property in Cairo, matters concerning the Jewish cemetery, internal taxation within the community and more, will help to outline the demographic patterns of the Jewish community in the city during the sixteenth and seventeenth centuries, and to reconstruct the activities of the community's leadership bodies.

- 1. During the research, I was in charge of deciphering the various manuscripts (in item no. 1, together with Dr. Stampfer) that were published in the series. Most of the manuscripts published in the series were deciphered by me, and all were edited by me.
- 2. I added historical commentary to the manuscripts I deciphered. The historical introductions to the responsa, which clarify the historical, economic, and social background of the responsum, are largely based on my work.
- 3. As part of the research, I traveled several times to Cambridge University and stayed there as a guest of the Genizah Research Unit. During my stay, I worked on cataloging and identifying new fragments of questions and answers from the Genizah collections at Cambridge, and many fragments published in this series were identified by me for



the first time. The construction of the corpus of documents for the book series was made possible to a considerable extent thanks to my work at the Cambridge University Library.
